BLOOD THINNER DRUG XARELTO LINKED TO SERIOUS BLEEDING EVENTS

Alley, Clark & Greiwe is investigating claims of persons severely injured while taking the blood thinner Xarelto. Xarelto (rivaroxaban) is a relatively new drug developed by Janssen Pharmaceuticals and Bayer. The drug was approved for sale in the U.S. by the FDA in 2011. It is prescribed to treat or prevent blood clots including deep vein thrombosis (DVT) and pulmonary embolism. Xarelto is also prescribed to patients with atrial fibrillation (a heart rhythm disorder) to lower the risk of stroke.

Xarelto is an alternative to Coumadin (warfarin). While patients on Coumadin require frequent lab monitoring and dose adjustments, patients on Xarelto do not. It is this advantage that has been a key selling point. However, Xarelto has been linked to serious bleeding events including hemorrhage, GI bleeds, and even death. The additional problem with

Xarelto is the absence of an approved reversal agent or antidote that can stop uncontrollable, sometimes fatal, bleeding. This is a similar problem linked to another newer-generation blood thinner called Pradaxa (dabigatran) which was subject to widespread litigation in the US. UPDATE ON TRANSVAGINAL MESH LITIGATION

SERIOUS COMPLICATIONS ASSOCIATED WITH TRANSVAGINAL SURGICAL MESH INCLUDE:



- Erosion/Protrusion of Mesh through the Vaginal Wall
- Extreme Pelvic Pain
- Bleeding
- Dyspareunia (painful intercourse)
- Vaginal Scarring/Shrinkage Deformity
- Multiple Surgeries to Remove Embedded Mesh
- Severe Emotional Distress
- Recurrent, Chronic Infections

It has been reported that the number of cases filed against the various transvaginal mesh manufacturers in the U.S. exceeds 50,000. Given the number of filings across the country, it seems clear that trial dates for each and every case is not possible. However, the bellwether trial process continues and we remain hopeful that these “test cases” may lead to meaningful settlement discussions with the manufacturers. Overall, there have been several successful trials for Plaintiffs as well as a few verdicts for the Defendants. All of the Plaintiff verdicts to date involved women who underwent multiple surgeries and continuous medical treatment for injuries associated with their pelvic mesh implants. Every case is different not just because every woman’s injuries and treatment courses may be different, but also because different state laws apply. This impacts everything from the type of vital evidence allowed to be presented to the jury to whether punitive damages can be pursued.

Recent Transvaginal Mesh Jury Verdicts

July 2014	Massachusetts	Albright v. Boston Sci.	Defense verdict. This was the first trial of Boston Scientific mesh claim in U.S.
Aug 2014	Massachusetts	Cardenasv. Boston Sci.	Defense verdict.
Sept 2014	Texas	Salazar v. Boston Sci.	Jury verdict of \$73.4 million. Verdict reduced to \$34.6 million under Texas State tort reform law limiting punitive damages. Defendant appealing verdict.
Sept 2014	West Virginia (MDL)	Huskey v. Ethicon	Jury verdict of \$3.27 million. Defendant has requested retrial and it is under consideration by Judge Goodwin.
